Subject: An Explanation of Federal Holidays

As a government agency, we think it is important that our employees understand the history of our country's federal holidays. Below is a brief review.

In 1870, Congress passed a law that officially recognized four federal holidays.

Finally, Congress passed a law in 1983 to set aside the third Monday of January to honor the accomplishments of
